I. CALL TO ORDER – Seann Frazier, Chair

II. PRELIMINARY MATTERS

A. Consideration of Minutes

The minutes for the Council's June 26, 2009 meeting were approved with minor changes.

B. Treasurer's Report

Scott Boyd gave the Treasurer's Report. The Section is in good financial shape. Like other sections, the Section has not made money on recent live CLE programs. Program CD sales are generating the profits for CLE programs.

C. Chair's Report

Seann Frazier urged caution with spending in the coming year, noting that some other sections lost money last year. Seann reported that the Section issued a request for proposals to revamp the Section's website.

III. COMMITTEE/LIAISON REPORTS

A. Continuing Legal Education

Bruce Lamb presented the ALS CLE Report. Bruce has been investigating the possibility of conducting one-hour telephone CLEs, which would be followed-up with tapes and CDs offered for sale. After discussion, it was decided that further information is needed, including a determination of how many participants would be necessary to break even. Bruce is working with The Young Lawyers Division to present an introductory level administrative law CLE in April 2010. CLE to support the State and Federal Government and Administrative Practice (SFGAP) board certification was also discussed. Currently, over 100 attorneys have been

certified in SFGAP. The Board of Governors is considering whether to discontinue new certifications in areas of law with less than 100 certified attorneys.

B. Publications

Scott Boyd presented the publications report. The next issue of the ALS newsletter will contain an article by Fred Dudley on the Small Business Legislative Advisory Council. Seann Frazier is working on an article on APA standing and Amy Schrader is writing an article on public records. Scott Boyd discussed writing an article on the requirement to electronically link materials referenced in the online Florida Administrative Code. The Administrative Law Practice Manual will go to print soon. Administrative Law Judges Linda Rigot and Kent Wetherell were recognized for all their hard work on this project.

C. Legislative

Judge Linda Rigot presented the Legislative Committee report.

D. Public Utilities Law

Cindy Miller presented the Public Utilities Law report.

E. Membership

Deborah Kearney reported that the Section currently has 1177 members.

F. Webpage

Daniel Nordby presented the proposals submitted by three vendors (eLYK, Netphiles and the Remington Agency) in response to the Section's RFP for a contract to redesign and maintain the Section's webpage. eLYK was the lowest in cost at \$5,000 for redesign and \$40 per month for hosting. Netphiles' proposal was for \$6,000 for design and \$250/month for hosting. The Remington Agency bid \$12,000-15,000 for design and additional fees for hosting. Andy Bertron moved to authorize Daniel Nordby to negotiate a contract with Netphiles. The motion was seconded and approved. Seann Frazier moved to transfer \$1,500 from the Section's operating reserve to add to the \$5,000 already budgeted for the website upgrade. This motion was also seconded and approved.

G. Florida Bar Board of Governors

The Florida Bar Board of Governors ("BOG") Liaison Larry Sellers reported that the BOG had met twice since the Executive Council's last meeting in June. In response to two requests to the BOG Committee on Ethics for opinions concerning communications with entities represented by counsel, the BOG approved a staff opinion on a more narrow issue, ruling that an attorney need not assume that a state agency is represented by its General Counsel in every matter. The BOG also considered, among other matters, judicial candidate self-disclosure statements, declining IOTA income, court funding, and CLE income.

H. Law School Liaison

Debby Kearney presented the Law School Liaison Committee report. Law school writing competitions have not worked well for other sections. Debby is working with outgoing Law School Liaison Committee Chair Kent Wetherell on new ideas.

I. CLE Committee Liaison

Cathy Sellers presented The Florida Bar CLE Committee Liaison report. At its last meeting in Tampa, the Committee approved The Florida Bar staff to research the best electronic format for CLE materials. The Committee also discussed the fee differential for non-section members to attend a section's CLE.

J. Council of Sections

Seann Frazier presented the Council of Sections Liaison report. The majority of section made money last year but most sections were less profitable than the year before, due partially to loses on investments.

K. Section/Division Liaisons

L. DOAH Update

Judge Rigot provided the Division of Administrative Hearings ("DOAH") Update. DOAH expects to announce decisions on two Administrative Law Judge vacancies this month. DOAH is considering making e-filing mandatory. In conjunction with the new hires, several ALJs will be reassigned within DOAH. DOAH Chief Judge Bob Cohen will be the next President-elect of the National Association of Administrative Law Judiciary (NAAJL). DOAH will host NAAJL's next annual conference.

M. APD Volunteer Program Ad Hoc Committee

Andy Bertron presented the APD Committee report. Since the Executive Committee's last meeting, the First District Court of Appeal issued its opinion in Moreland v. APD invalidating the Agency for Persons with Disabilities' (APD) tier rules. In Washington v. Debeaugrine, District Court Judge Hinkle denied APD's motion to dismiss and issued a preliminary injunction prohibiting APD from reducing benefits for APD clients whose requests

for hearing were denied by the agency. These actions have caused APD to begin requesting continuances in tier cases before DOAH until the agency can promulgate new rules.

BOARD OF GOVERNORS REPORT
Amelia Island - December, 2009

The Florida Bar's Board of Governors met December 11, 2009 in Amelia Island.

The Board approved a new legislative position that will advocate the rights of minors in the dependency system to have an attorney represent their interests, and that certain "critical categories" of children in the State's care should get publicly provided lawyers. This legislative position stipulates however, that funding for such lawyer representation is not to come at the expense of that State's Guardian Ad Litem Program.

The Board Review Committee on Professional Ethics has voted to draft amendments to Florida Ethics Opinion 07-3, which addresses outsourcing of legal work. The amendments would require the informed consent of clients before outsourcing confidential information. Amendments to the Rules Regulating The Florida Bar will be proposed addressing either notice to third parties or redaction before outsourcing sensitive financial or medical information.

The Board voted to again table an appeal from a staff ethics opinion regarding "reverse contingency fee" representation on medical lien negotiations. The staff opinion held it would likely result in an excessive fee if a lawyer working on a contingency fee hired another lawyer under a reverse contingency fee to handle medical lien negotiations. The Board voted to refer it to the appropriate committee to consider an amendment to the Rules Regulating The Florida Bar addressing the subject.

The Board voted to place a six-month moratorium, beginning January 1, 2010, on the enforcement of the new Bar advertising rules affecting Web sites in order to give Bar members time to comply with the rules. The Board also approved a policy on attempted voluntary filings of lawyer Web sites that Bar staff will not review the entire contents of a Web site even if a lawyer files that voluntarily, but will respond to specific questions involving a specific phrase or

image to be included on a Web site.

It was reported that there continue to be ongoing efforts on e-filing for the state court system, and efforts to establish an Internet portal for electronic filing. Clerks and the courts are trying to work out their differences over who would run the portal. The Bar is working to help that along and will push for a filing system that will be uniform statewide.

The Board approved a recommendation from the Program Evaluation Committee to create the Special Committee to Study the Decline of Jury Trials, as requested by President-Elect Mayanne Downs. The panel will study the decline of jury trials, at both the state and federal level, to determine the impact the decline has on the justice system and whether any action is needed.

It was noted that the new "Career Center" website has been very successful. Many potential employers, and employees, have logged on to the site regarding available attorney positions at firms throughout the state.

Please also note that the Florida Supreme Court has issued an order amending the Bar's advertising rules. In its order, the court declined to adopt the Bar's request to delete the requirement of an oral disclaimer every time a nonlawyer spokesperson is used in television or radio ads. Therefore, such a disclaimer is still required on any radio and television advertisements, including public service announcements such as sponsorships of National Public Radio and Television.

Administrative Law Section

Approved legislative positions for the 2008-20010 biennium are as follows:

July 25, 2008

1. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation, that undermines the rule-making requirements of the Administrative Procedure Act by allowing statements of agency policy without formal rule-making.
2. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation to deny, limit or restrict points of entry to administrative proceedings under Chapter 120, *Florida Statutes*, by substantially affected persons.
3. Opposes exemptions or exceptions to the Administrative Procedure Act, but otherwise supports a requirement that any exemption or exception be included within Chapter 120, *Florida Statutes*.
4. Supports voluntary use of mediation to resolve matters in administrative proceedings under Chapter 120, *Florida Statutes*, and supports confidentiality of discussions in mediation; but opposes mandatory mediation and opposes imposition of involuntary penalties associated with mediation.
5. Supports uniformity of procedures in administrative proceedings under Chapter 120, *Florida Statutes*, and supports modification of such procedures only through amendment of or exceptions to the Uniform Rules of Procedure.
6. Opposes amendments to Chapter 120, *Florida Statutes*, or other legislation that limit, restrict, or penalize full participation in the administrative process without compelling justification.
7. Supports adequate funding of the Division of Administrative Hearings and other existing state administrative dispute resolution forums in order to ensure efficient resolution of administrative disputes.
