MINUTES ADMINISTRATIVE LAW SECTION EXECUTIVE COUNCIL MEETING

April 5, 2007

Tallahassee, Florida

Draft: not yet reviewed or approved by Executive Council

I. CALL TO ORDER: Executive Council Chair-Elect Andy Bertron called the meeting to order at 3:05 pm.

<u>Present</u>: Andy Bertron, Elizabeth McArthur, Seann Frazier, Kent Wetherell, Bill Williams, Dave Watkins, Linda Rigot, Clark Jennings, Debby Kearney, Allen Grossman, Wellington Meffert, Donna Blanton, Cynthia Miller, Cathy Lannon, Larry Sellers, Daniel Nordby, and Jackie Werndli.

II. PRELIMINARY MATTERS:

A. <u>Minutes — February 9, 2007</u>

The minutes of the February 9, 2007, Executive Council meeting and Long-Range Planning Retreat were approved with one correction to indicate that Andy Bertron is Chair-Elect.

B. <u>Treasurer's Report</u>

Seann Frazier reported that the Section is well ahead of budget right now, but that not all of the expenses from the 2006 Pat Dore Conference had been allocated yet, and we still do not know what impact The Florida Bar's new expense allocation system will have.

C. <u>Chair's Report</u> None.

III. COMMITTEE/LIAISON REPORTS

A. Continuing Legal Education

Seann Frazier reported that the Section has been asked to co-sponsor a state and federal administrative and governmental practice certification review course to be held on August 16-17, tentatively planned for Jacksonville, along with the Government Lawyers Section and the Environmental and Land Use Law Section, with each Section bearing 1/3 of the financial responsibility. The low number of applicants to take the certification exam was noted. After discussion, on motion made and duly seconded, the council voted to agree to 1/3 co-sponsorship of this program if it is held in Tallahassee. Bill Williams and Allen Grossman abstained from this vote.

IIA 1(1)

Seann Frazier reported that it looked like there would not be a basic administrative law Young Lawyers' Division seminar in spring 2008, leaving the spring 2008 slot open. Apparently a very large amount of lead time is necessary to coordinate a YLD seminar, and after discussion, it was agreed that the council should make known now its willingness to support a basic administrative law YLD seminar in spring 2009, to give enough lead time to allow this program to happen.

Seann Frazier also reported on the Government Lawyers' Section's request that the Section support and assume a 10% share of the financial responsibility of an April 2008 federal APA seminar to be held in Washington, D.C. It was noted that last year's federal APA seminar lost money, although some changes have been discussed to reduce the costs. After discussion, on motion made and duly seconded, the council voted to fully support the federal APA seminar but not to share in the financial responsibility. Support for this program will include lending the Section's name to the seminar if that is desired, and providing space to advertise for the program in the Section newsletter and on its website. Bill Williams and Allen Grossman abstained from this vote.

Jackie Werndli provided an update on CLE cost/revenue allocation issues that are being worked out and remain fluid with The Florida Bar. One change that has been agreed to is that the per-format charge for CLE audiotapes and videotapes has been reduced from \$900 to \$750, but that the per-order change fee is staying at \$15 and the per-tape fee is going up from \$10 to \$15. It will be the end of the year or later, after the audited statements are reviewed, before these allocation issues are finalized.

Jackie Werndli then discussed how these allocation issues will affect the Section's financial performance from the 2006 Pat Dore Conference. If that conference is treated as a Section-sponsored program, then a problem caused by the new allocation system is that there is still the old policy adopted by The Florida Bar in 1993 when there was no allocation of direct expenses to Section seminars that a Section cannot make more than \$3,000 on any one program, and if there are multiple programs in one year, then no more than \$5,000 can be made in any one year, with any excess profit going back to The Florida Bar. Another negative financial impact is a new treatment of seminar tape revenues as being newly allocated to the courses (so that if there is a profit from the tape sales, then that profit is subject to the cap). If the seminar is treated as a CLE course of The Florida Bar and not of the Section, however, then the cap does not apply, but The Florida Bar will typically be in control of setting the fee for the program. It may be possible for the 2006 Pat Dore Conference to be treated as a CLE course of The Florida Bar, which may be better financially for the Section given all of the new revenue and cost allocations. On motion made and seconded, the council voted to authorize Jackie Werndli to proceed to characterize the 2006 Pat Dore Conference however yields the best financial results for the Section.

B. Publications

Debby Kearney reported that she has several articles lined up for the next several issues of The Florida Bar *Journal*.



Elizabeth McArthur reported that the March issue of the Newsletter had just come out, and that it had a General Counsels directory instead of agency snapshots, noting that there have been several recent newsletters without any agency snapshots and volunteers are needed. Seann Frazier volunteered for an agency snapshot update on the Agency for Health Care Administration, and Allen Grossman agreed to do an agency snapshot update on the Department of Health. All members were encouraged to check the agency snapshot page of the Section's website, and to volunteer to do agency snapshots for those agencies that had not yet been covered.

C. <u>Legislative</u>

Bill Williams reported on APA-related bills. SB 1592 deals with unadopted rules and removes the caps on attorney's fees in rule challenges. SB 1594 deals with incorporation by reference and codifies the case holding that there is a right to a formal administrative hearing when disputed issues of fact arise during the course of an informal hearing. Linda Rigot noted that SB 1970 deals with agency exemptions, following up on the Senate Committee on Governmental Oversight's study on the need to continue existing exemptions. Not very many exemptions were identified as no longer necessary as a result of this effort.

D. <u>Public Utilities Law</u>

Cindy Miller reported that the seminar conducted at the Mary Brogan Museum went well, and that the different venue was well-received.

E. <u>Membership</u>

Kent Wetherell reported that Section membership was up by just over 100 so far this year. He will be speaking at a Young Lawyers Division – Tallahassee Bar program to be held at FSU, and he will make Section brochures available there.

F. Webpage

Daniel Nordby reported that the website now has newsletters going back for 10 years, and all agency snapshots accessible on a separate page. They are working on technical issues for Listserv, and plan to get some information out in the next newsletter.

G. <u>Uniform Rules of Procedure</u>

Linda Rigot reported that the Joint Administrative Procedures Committee had indicated that the Governor's office had agreed to proceed with two changes to the Uniform Rules. She has signed up on the list of persons to get notice of any proposed rule amendments, and will watch for the changes. Cathy Lannon reported that the Tallahassee Women Lawyers will be doing a CLE seminar on the amendments to the Uniform Rules.

H. Board of Governors Liaison

Larry Sellers reported on the March 30 meeting of The Florida Bar Board of Governors, including its approval of a proposed advertising rule amendment on attorney and law firm websites, which now goes to the Supreme Court. The Board of Governors also approved a proposal for listing Bar members' ten-year disciplinary history on The



Florida Bar's website, and approved changes to Rule 4-8.4(i) addressing sexual conduct with clients; these changes also go to the Supreme Court.

V. NEW BUSINESS

Cathy Lannon requested that the Section consider sponsoring group showings of CLE videotapes so that those showings would qualify for "live" CLE presentations for purposes of qualifying for certification requirements. The council raised questions regarding costs, charges, and other issues implicated by this request, and determined that there was not enough information regarding what would be required to qualify for a live presentation. On motion, duly seconded, a majority of the council voted to authorize Jackie Werndli to find out whether it is feasible to get in-person credit for group airings of CLE tapes, and if so, what are the cost and charge issues, and report back to the council; but to not authorize any action by the Section on this request at this time. Cathy Lannon voted against the motion.

Andy Bertron announced that the next meeting would be at The Florida Bar's annual meeting, with the council meeting the afternoon of June 28, and the Section's reception held that night. Jackie Werndli noted that information about the annual meeting, with hotel and other information, was on The Florida Bar's website, and she would be sending an email reminder with a link.

On motion, duly seconded, the meeting was adjourned at 4:55 pm.

The Florida Bar 06-07 CLE year is coming to a close and appears to be our best year in the past 10 in registration/sales numbers. Attendance and aftermarket sales (Audio, CD DVD and Video) numbers have exceeded 30,000 with approximately \$5.1 million in gross revenue. The May financial statements show section accounts collectively have been credited with over \$600,000 in cle revenue plus \$153,325 in section differential fees.

At the start of this fiscal year, the Board and staff requested that sections participating in Bar CLE programs give the new financial arrangements for CLE at least one full year in operation before efforts are made to refine the system. In most instances the changes have been beneficial to the cosponsoring section.

The Florida Bar CLE e-Newsletter, sent monthly to our members by LexisNexis, may be the single largest factor in our increased sales. The e-Newsletter highlights the latest in CLE Programs and Publications with a direct link to our CLE registration page. In addition to the e-Newsletter we added video locations to selected programs to provide easier access for our members and added CD's to our A/V catalog. A free BoG program on the discipline system was hosted by Legalspan (our cle online host) and attracted new users to our online delivery system.

Administrative Law Section 2006-2008 Legislative Biennium July 28, 2006

- 1. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation, that undermines the rule-making requirements of the Administrative Procedure Act by allowing statements of agency policy without formal rule-making.
- 2. Opposes any amendment to Chapter 120, *Florida Statutes*, or other legislation to deny, limit or restrict points of entry to administrative proceedings under Chapter 120, *Florida Statutes*, by substantially affected persons.
- 3. Opposes exemptions or exceptions to the Administrative Procedure Act, but otherwise supports a requirement that any exemption or exception be included within Chapter 120, *Florida Statutes*.
- 4. Supports voluntary use of mediation to resolve matters in administrative proceedings under Chapter 120, *Florida Statutes*, and supports confidentiality of discussions in mediation; but opposes mandatory mediation and opposes imposition of involuntary penalties associated with mediation.
- 5. Supports uniformity of procedures in administrative proceedings under Chapter 120, *Florida Statutes*, and supports modification of such procedures only through amendment of or exceptions to the Uniform Rules of Procedure.
- 6. Opposes amendment to Chapter 120, *Florida Statutes*, that limits, restricts, or penalizes full participation in the administrative process, in the absence of compelling justification or non-anecdotal evidence which demonstrates that the existing provisions of law are not adequately protecting the administrative due process rights of all participants.



At its June 1 meeting in Key West, The Florida Bar Board of Governors:

- Heard a report from Supreme Court Justice Raoul Cantero, who is chair of the Supreme Court Commission on Professionalism that the commission and Frank Angones are appointing a committee to explore having required mentoring for new Bar members. Cantero said the commission was impressed with a first-in-the-nation mentoring program created by the State Bar of Georgia.
- Approved the recommendations reported by Marc Jimenez, Chair of the Attorney-Client Task Force, including adopting a five-part five legislative position for The Florida Bar stemming from those recommendations. Those recommendations generally oppose any impingement on the attorney-client relationship or work product protections made by government attorneys as part of investigations.
- Heard board members express reservations about the state's new regional conflict counsel plan, including concerns of whether the program, which begins October 1, is adequately funded and will provide effective representation.
- Approved final details for the merger of the Practice Management and Development Section to the General Practice, Solo and Small Firm Section.
- Heard about final details for placing information about lawyers discipline history for the past 10 years on the Bar's Web site.
- Heard details about how lawyers can add information about themselves and their law firm to their bio page on the Bar's Web site, pursuant to a program put in place by the Communications Committee. The committee is also exploring the possibility of letting lawyers report their probono service through the Bar Web site, instead of only on the annual Bar dues statement.
- Approved a rule change to clarify that lawyers cannot belong to a private lawyer referral service unless that service follows all Bar rules. Also passed was a new standing board policy to keep judges informed when they make a complaint about a lawyer's conduct to the disciplinary system.
- Rejected a motion to reconsider the board's authorization for the Real Property, Probate and Trust Law Section to oppose changes to a Florida law that limits who can serve as a personal representative for an estate. Still pending at the Legislation Committee is a request from the Out-of-State Practitioners Division for the board to approve as a Bar-wide legislative position the division's position of seeking a change to the law to allow out-of-state Bar members to serve as personal representatives.

MAJOR ACTIONS OF THE FLORIDA BAR BOARD OF GOVERNORS 2006-2007

Established a "bright line" rule on using doctor of laws in lawyer advertising, allowing lawyers to use only the terms actually on their diplomas and not allowing translation of that wording into another language.

Approved a joint Bar-judiciary committee to study a way to evaluate the performance of Florida's judges and communicate those evaluations to the public.

Approved a recommendation that government lawyers be exempted from the new Bar rule requiring all Bar members to designate an inventory attorney pending Supreme Court adoption.

Approved a modification of Ethics Opinion 77-30 which gives more leeway in identifying conflicts with a city or county attorney representing a single commission member in an ethics complaint before the state Ethics Commission. The revised opinion also provides more guidance on when any conflicts may be waived.

Approved a proposal from the Equal Opportunities Law Section and Board of Legal Specialization and Education to include "bias elimination in the legal system" among the five mandatory CLE credits. Currently, Bar members must take five credits in ethics, professionalism, and/or substance abuse training as part of the 30-hour requirement.


Endorsed the three-year cycle rules changes proposed by the Civil Procedure Rules Committee, the Probate Rules Committee, and the Small Claims Rules Committee.

Received a report showing that the recommendations of the Special Commission on Lawyer Regulation have been referred to various board committees for review.

Adopted a position in support of Amendment 3 requiring broader support for amending the Florida Constitution.

Approved the creation of a Florida Registered Paralegal Program Committee for Supreme Court adoption.

Declined to endorse a proposed rule of criminal procedure dealing with closing arguments promulgated to replace a rule the legislature repealed last session. The board voted to withhold its support for proposed criminal rules 3.250 and 3.851 – written by the Criminal Procedure Rules Committee – that would give the prosecution the closing argument in cases where the defense calls only the defendant to testify and no other witnesses. Instead, the board adopted the committee's minority report as its own. The rule will still be presented to the



Supreme Court as drafted by the committee – but with the board's objection noted – for final action.

Endorsed amendments offered by the Criminal Procedure Rules Committee to amend Rules 3.131 and 3.132, which concern pretrial release of defendants charge with violent crimes.

Authorized the Public Interest Law Section and the Legal Needs of Children Committee to oppose the indiscriminate use of chains and shackles on juvenile defendants during court proceedings. The board also approved allowing the Legal Needs of Children Committee to advocate for legislation to require all children have a meaningful opportunity to consult with an attorney before waiving the right to counsel in a delinquency proceeding.

Approved a recommendation to join the Supreme Court's Commission on Professionalism in asking the court to withdraw the commission's request for a Bar rule change that would allow judges to impose up to a \$500 fine and order attendance at a professionalism course for lawyers who show unprofessional conduct in court.

Renewed several legislative positions from the 2004-06 biennium and adopted two new positions – opposing the indiscriminate shackling of juveniles when they appear in criminal cases and supporting a student loan repayment program for state government and legal aid attorneys.

Heard Justice Peggy Quince, appearing on behalf of Chief Justice Fred Lewis, ask the Bar to continue supporting a pay equity plan for nonjudicial court employees and to support the chief's reconstitution of the Judicial Management Council which assists the court on a variety of upcoming issues including long-range planning.

Heard Justice Barbara Pariente report that the number of lawyers performing pro bono work for the poor is declining, as are the hours and monetary contributions made by lawyers to legal aid programs. She and board members discussed several ways to reverse that trend.

Approved a Bar legislative position supporting the Supreme Court's certification for the need of 37 new judges this year.

Agreed to a request from the Criminal Law Section Executive Council that the Bar direct its legislative lobbyists to support improved funding for legal services for the indigent, and an early release of state funds in the current budget year allocated for those purposes because of a serious shortfall. The services affected include paying for court interpreters, court reporters, conflict public defenders and similar services.

Approved a proposal from the Communications Committee to provide an easier way for Bar members to get a password to access secure areas of the Bar's Web site.

Approved that all future public reprimands be administered in front of the Board of Governors, unless waived by a two-thirds vote of the board.

III H2(2)

Voted to co-sponsor a New York State Bar resolution at the ABA House of Delegates critical of a recent Defense Department official's call for corporations to stop hiring lawyers doing pro bono representation of Guantanamo detainees. The board also directed the delegates it appoints to the House to support that resolution. Board members noted the resolution is consistent with long-standing Bar support of pro bono work by lawyers.

Heard a report from the Board of Legal Education and Specialization that all but four certification areas have sections on ethics and professionalism in their certification exams. The BLSE adopted a motion requiring that all certification exams to include a segment on ethics and professionalism.

Approved a proposed advertising rule amendment on attorney and law firm Web sites, pending Supreme Court approval. The rule requires the opening, or homepage, of a Web site comply with all advertising rules except that it be submitted for Bar review. Inside pages could also within guidelines use testimonials, references to past results, and statements characterizing the quality of the lawyer or law firm's work.

Approved the Bar's 2007-08 budget, which has no change in Bar members' annual fees and projected revenues of \$36.9 million and expenses of \$36.3 million.

Approved the Communications Committee's proposals for listing Bar members' 10-year disciplinary history on the Bar's Web site.

Approved changes to Rule 4-8.4(i) on sexual conduct with clients. The amendment, which now goes to the Supreme Court, would create a rebuttable presumption that sexual conduct with a client initiated after the start of representation harms the client or the handling of the client's case.

Endorsed several procedural amendments recommended by several rules committees relating to the Supreme Court's request for input on the recommendations from the Committee on Privacy and Court Records. The recommendations dealt with protecting Social Security numbers and other information that could be used to steal a party's identity.

Endorsed a Criminal Procedure Rules Committee recommendation that no changes be made in the rule on speedy trials which the committee had been studying at the request of the Supreme Court.

Nominated three lawyers for each upcoming vacancy on the state's 26 judicial nominating committees. The final appointments will be made by Gov. Charlie Crist.

Heard Attorney General Bill McCollum discuss his office's operations and his two top priorities -- protecting children from Internet-enabled sexual exploitation and combating gang violence.

Received a report from Supreme Court Justice Raoul Cantero, who is chair of the Supreme Court Commission on Professionalism, that the commission and President-elect Frank Angones are appointing a committee to explore having required mentoring for new Bar members.

Approved the recommendations of the Attorney-Client Task Force, including adopting a five-part legislative position for The Florida Bar, generally opposing any impingement on the attorney-client relationship or work product protections made by government attorneys as part of investigations.

Discussed reservations about the state's new regional conflict counsel plan, including concerns of whether the program, which begins October 1, is adequately funded and will provide effective representation.

Approved final details for the merger of the Practice Management and Development Section to the General Practice, Solo and Small Firm Section.

Reviewed details on how lawyers can add practice information to their bio page on the Bar's Web site, pursuant to a program put in place by the Communications Committee.

Approved a rule change to clarify that lawyers cannot belong to a private lawyer referral service unless that service follows all Bar rules. Also passed was a new standing board policy to keep judges informed when they make a complaint about a lawyer's conduct to the disciplinary system.




